



## GENERAL TERMS AND CONDITIONS

### Definition

The Salon Agricole International Tech&Bio is organised by the Chambre d'Agriculture de la Drôme (CA26) hereinafter referred to as the "Organiser". The CA26 has appointed K.I.T. Group France as PCO (Professional Congress Organiser) for the coordination and implementation of the registration management system at Tech&Bio 2023, hereinafter referred to as the "Salon".

### General Terms and Conditions – Registration

These general terms and conditions are valid for each attendee registered for Tech&Bio 2023 which will take place in Bourg-lès-Valence, France, on the 20th et 21st of september. Any person, delegate, allied professional, student, media representative, speaker, or exhibitor may be considered an attendee.

### Registration

The registration deadlines are as follows:

Online registration : Until 19 September 2023 23:59 CET

Onsite registration : September 20 & 21, 2023

Only fully completed registrations will be accepted. Registration will only be confirmed upon receipt of payment in full.

Should the maximum attendee capacity be reached, the organiser reserves the right to refuse any additional registration.

Any participant under 18 years of age must be accompanied by an adult in order to enter the site.

The registration fee for Show participants includes admission to all areas of the Trade Show, unless otherwise stated on site.

### Methods of payment

The registration fee must be enclosed with all Tech&Bio 2023 registrations. Payments must be made in advance and in EURO (€) only, by credit card (Visa or Mastercard).

### Receipt

A receipt will be sent to you by the Registration Department of K.I.T. Group France after receipt of your complete registration and the corresponding payment.

### Badges

All visitors must be able to show their badge, paper or digital, when they enter the Show. If a participant misplaces or forgets his/her badge, it is possible to print a new badge. The new badge replaces the old one, therefore the old one will become invalid.

The badge is strictly personal and must be worn at all times and be visible inside the site and throughout the Congress.

As a reminder, anyone wishing to take part in the Tech&Bio 2023 trade show **must** register.

An exhibitor badge is personal, nominative and linked to the company exhibiting at Tech&Bio 2023. It may not be transferred to a third party. Without registration, access to the Show will be refused.

### Registration cancellation policy



No refunds will be made.

### **Modification of the programme**

The trade show programme is published as an indication only and may be subject to modification.

### **Cancellation of the Trade Fair, Force Majeure**

In the event that the Trade Show cannot take place or has to be postponed due to events beyond the Exhibition Organiser's control, including but not limited to the following: force majeure, strikes, workplace disputes, government requisitions, government advice, travel restrictions or regulations concerning travel, availability of hotels or facilities, goods or supplies, war or any apparent act of war, terrorism, natural or man-made disasters, civil unrest, disease, epidemic or pandemic, curtailment or restriction of transportation, or any other comparable calamity, loss or condition (collectively, a "Force Majeure Event") or as a result of events that cannot be attributed to any prejudicial intention or gross negligence on the part of the Exhibition Organiser, the Exhibition Organiser has the right to cancel the Show immediately and/or terminate the Show without any liability whatsoever and is released from its obligations towards the participant.

Furthermore, if the Show is terminated due to or following a case of Force Majeure, the Show Organiser may not be held liable by the participants for any damage, loss or costs, such as transport costs, hotel or financial losses, etc. In these circumstances, the Show Organiser reserves the right either to retain the total amount of the registration fee and use it for a future Show, or to reimburse the participant after deducting from the amount the costs already invested in the organisation of the Show and which could not be reimbursed by a third party.

### **Data Protection and Sharing of contact details**

The collection, processing (including data storage, changes, transmission, blocking and deletion) and use of all personal data of the registration are carried out in compliance with the legal provisions on data protection.

K.I.T. Group France collects and stores personal data for the preparation and implementation of the Congress.

When you register, you are invited to fill in the online form and to indicate the following information: name, address, e-mail, telephone number and your reservation preferences. This information is essential for the proper execution of your registration or reservation (in particular for sending the reservation confirmation).

If you choose to pay by credit card, you will also be asked for credit card details (credit card type and number, security code, expiration date, name of cardholder).

All this information will be treated and stored confidentially and in compliance with the legal provisions on data protection.

In order to guarantee and protect the data you have transmitted to us, the information is transferred by means of a secure server which encrypts all your personal data as well as your credit card data. The encryption method used is the industry standard Transport Layer Security (TLS). Our TLS certificate has been issued by UTN - usertrust.com.

In addition, technical and personnel security procedures are in place to limit access to and use of personal data. Only authorized employees may access it in the course of their duties related to our services.

Our server and network are protected by firewalls and we have an alarm system in place to detect and manage intrusions and/or abuse of our server.

Your credit card details will be retained by K.I.T. Group France for three months after the date of the Congress.

In addition, the Congress organizers may periodically share personal contact details with third parties, who may contact participants regarding activities offered at the Congress or provide information that may be of interest



to them. Therefore, data may be passed on to third parties unless the participant has expressed a contrary opinion. Your full contact details will only be passed on if:

- you give your explicit consent,
- a third party proves to the Congress organizers that you have violated the rights of that third party and thus requests the disclosure of your data,
- the Congress organizers are obliged to pass on your data, e.g. because of an official request or legal proceedings.

Participants can use their barcode badge as a business card that can be scanned by exhibitors or other partners, who would then have their contact information. In this case, the participant alone decides with whom he will share his data. Please also note that by agreeing to have your badge scanned at the exhibitors' booths or during the symposiums, you agree that the exhibiting/organizing company may contact you using the data provided at registration.

#### **Authorization to use the image of a person in terms of photographic, video or audio material for the documentation of the event or its media coverage**

By accepting these terms and conditions, the event participant explicitly agrees to the creation of images, films and audio documents representing him/her in the context of the JFR 2023 and authorizes their use, sharing and publication for documentation and communication purposes, in particular on social networks (Twitter, Facebook, Instagram) and this without financial consideration.

#### **Liability**

The Congress organisers shall be held liable in the framework of a duty of care as a respectable business person according to statutory provisions. The liability of the conference organisers - for whatever legal reason - shall be limited to intent and gross negligence.

To the extent permitted by applicable law, K.I.T. Group, including all its management, representatives, fully or partially employed staff, and/or the Governing Board of the SFR shall not be liable for any direct, indirect or consequential damages of any kind, loss of profits and/or loss of data arising from and in connection with the access and use of the platform and the participation in the JFR. The liability of commissioned service providers shall remain unaffected by this.

The attendee shall take part in the JFR at his/her own risk. Oral agreements shall not be binding if these have not been confirmed in writing by the Congress organisers.

K.I.T. Group and its client the SFR do not warrant the adequacy, accuracy and/or completeness of any information conveyed during the JFR 2023 and published on the platform. The organisers do not guarantee uninterrupted and/or error-free access to the platform of the Congress. The organisers endeavours to fix such interruptions as fast as possible. In all other respects, the regulations from the connectivity or technical issues section apply.

#### **Applicable Law**

This contract shall be governed by, interpreted and enforced in accordance with French law. Any dispute concerning the interpretation or the execution of the present contract will be submitted, in the absence of amicable settlement, to the competent courts of the jurisdiction of the Commercial Court of Paris, France.

#### **Severability clause**

If there is a determination of these Terms and Conditions to be ineffective or impracticable, then the validity of the Terms and Conditions remaining are not impaired. The parties are obligated to cooperate in order to replace the ineffective or impracticable clause by an effective or feasible clause, which results in the ineffective or impracticable clause being closed.

#### **Right of modification**

K.I.T. Group may make changes and/or additions to these General Terms and Conditions at any time. The attendees will be informed of such revisions from time to time. If the changes and/or amendments concern



essential parts of the contract and if the rights of the attendees are substantially changed as a result, each attendee with an existing and paid registration will be informed separately with the possibility of consent.
