Terms and conditions

Definition

The Tech&Bio International Agricultural Show is organized by the Chambre d'Agriculture de la Drôme (CA26), hereinafter referred to as the "Organizer". The CA26 has appointed K.I.T. Group France as PCO (Professional Congress Organiser) for the coordination and implementation of the registration management system for the Tech&Bio 2025 Show, hereinafter referred to as the "Show".

General terms and conditions of sale for registrations

These terms and conditions apply to anyone registered for Tech&Bio 2025, which will take place in Bourg-lès-Valence, France, on September 24 and 25. All persons registered for the show, exhibitors, guests and visitors are considered participants.

Registrations

The following deadlines apply to registration fees:

Online registration: until September 25, 2025 - 17:59 CET

On-site registration: September 24 and 25, 2025

Only complete registration forms will be accepted. Registration will be confirmed only after full payment has been received.

If the maximum number of registrants is reached, the Organizer reserves the right to refuse any additional registrations.

All participants under 18 years of age must be accompanied by an adult in order to enter the site.

Registration fees for Show participants include admission to all areas of the Show, unless otherwise stated on site.

Means of payment

Registration fees must be enclosed with all Tech&Bio 2025 registrations. Payments must be made in advance and in EURO (€) only, by credit card (Visa or Mastercard).

Receipt

A receipt will be sent to you by the K.I.T. Group France Registration Department upon receipt of your complete registration and corresponding payment. Group France after receipt of your complete registration and payment.

Badges

Each visitor must be able to present his or her badge, paper or digital, when present at the show. If a participant misplaces or forgets his/her badge, a new one will be printed at the registration desk. The new badge replaces the old one, which will become invalid.

The badge is strictly personal. It may not be transferred, and no one may carry out formalities on behalf of another.

As a reminder, anyone wishing to take part in Tech&Bio 2025 must register.

An exhibitor badge is personal, nominative and linked to the company exhibiting at Tech&Bio 2025. It cannot be transferred to a third party. Without registration, access to the Show will be refused.

Cancellation conditions

No refunds will be made.

Program modification

The Show Organizer reserves the right to modify the program, which is published for information purposes only.

Show cancellation, case of force majeure

In the event that the Show cannot take place or must be postponed due to events beyond the control of the Show Organizer, including but not limited to: force majeure, strikes, workplace disputes, government requisitions, government advice, restrictions or regulations concerning travel, availability of hotels or facilities, goods or supplies, war or an apparent act of war, terrorism, natural or man-made disasters, civil unrest, disease, epidemics or pandemics, reduction or restriction of means of transportation, or any other comparable calamity, loss or condition (collectively, a "Force Majeure Event") or due to events that cannot be attributed to any prejudicial intent or gross negligence on the part of the Show Organizer, the Show Organizer shall have the right to cancel the Show immediately and/or terminate the Show without any liability and shall be released from its obligations to the participant.

Furthermore, should the Show be terminated due to or as a result of Force Majeure, the Show Organizer cannot be held liable by participants for any damages, losses or costs, such as transportation, hotel or financial losses, etc., incurred as a result of such termination. In such circumstances, the Show Organizer reserves the right either to retain the full amount of the registration fee and use it for a future Show, or to reimburse the participant after deducting from the amount the costs already invested in organizing the Show and which could not be reimbursed by a third party.

Protection and transmission of personal data

The collection, processing (including data storage, changes, transmission, blocking and deletion) and use of all personal registration data is carried out in compliance with the legal provisions on data protection. K.I.T. Group France collects and stores personal data for the preparation and implementation of the exhibition. When registering, you are invited to fill in the online form and provide the following information: name, address, e-mail address, telephone number and booking preferences. This information is essential for the proper processing of your registration or reservation (in particular for sending you confirmation of your reservation).

For payment by credit card, you will also be asked for credit card details (credit card type and number, security code, expiry date, cardholder's name). All such information will be handled and stored confidentially and in compliance with data protection regulations. In order to guarantee and protect the data you have transmitted to us, the information is transferred via a secure server that encrypts all your personal and credit card data. The encryption method used is the industry standard "Transport Layer Security (TLS)". Our TLS certificate has been issued by UTN - usertrust.com.

In addition, technical and personnel security procedures have been put in place to limit access to and use of personal data. Only authorized employees may access it in the course of their duties related to our services. Our server and network are protected by firewalls, and we have set up an alarm system to detect and manage intrusions and/or abuse of our server.

Your credit card details will be retained by K.I.T. Group France for three months after the show date.

In addition, the Show Organizer may periodically share personal contact details with third parties, who may contact participants regarding activities offered at the Show or pass on information that may be of interest to them. As a result, data may be passed on to third parties unless the participant has expressed an opinion to the contrary. Your full contact details will only be passed on if :

· you give your explicit consent,

- a third party proves to the Show Organizer that you have violated that third party's rights and thus requests disclosure of your details,

- the Show Organizer is obliged to pass on your data due to, for example, an official request or legal proceedings.

Participants can use their badge with QR code as a business card that can be scanned by exhibitors or other partners, who would then have their contact details. In this case, the participant alone decides with whom to share his or her data. Please also note that by agreeing to have your badge scanned on exhibitors' stands, you consent to the exhibiting/organizing company contacting you using the data provided at the time of registration. Authorization to use a person's image in photographic, video or audio material for event documentation or media coverage

By accepting these terms and conditions, the Show participant explicitly agrees to the creation of images, films and sound documents representing him/her as part of Tech&Bio 2025 and authorizes their use, sharing and publication for documentation and communication purposes, in particular on social networks (LinkedIn, Twitter, Facebook, Instagram) and without financial consideration.

Liability

The Show Organizer's liability is based on a duty of care in accordance with the statutory provisions. The liability of the Exhibition Organizer - for any legal reason whatsoever - is limited to intent and gross negligence.

To the extent permitted by applicable law, K.I.T Group France, including all of its officers, representatives, full-time or part-time staff, and/or the Tech&Bio 2025 Steering Committee shall not be liable for direct, indirect or consequential damages of any kind, lost profits and/or loss of data arising out of or in connection with access to and use of the platform and participation in the Tech&Bio 2025 Exhibition. The liability of commissioned service providers remains unaffected by this provision.

Participation in Tech&Bio is at the participant's own risk. Oral agreements are not binding unless confirmed in writing by the Exhibition Organizer.

K.I.T. Group France and the Organizer do not guarantee the adequacy, accuracy and/or completeness of the information transmitted during the Tech&Bio 2025 Show and published on the website. The Organizer does not guarantee uninterrupted and/or error-free access to the exhibition platform. The Organizer shall endeavor to remedy any such interruptions as quickly as possible. Otherwise, the provisions of the connectivity or technical problems section apply.

Applicable law

The present contract shall be governed, interpreted and executed in accordance with French law. Any dispute concerning the interpretation or execution of this contract shall be submitted, failing amicable settlement, to the competent courts of the Tribunal de Commerce de Paris, France.

Severability clause

Should any clause of these general terms and conditions of sale prove to be invalid or unenforceable, the validity of the remaining terms and conditions shall not be affected. The contracting parties are obliged to cooperate in order to replace the invalid or unenforceable clause with a suitable valid clause. This also applies to any gaps in these general terms and conditions.

Modification rights

K.I.T. Group France may make changes and/or additions to these terms and conditions at any time. Participants will be informed of such revisions. If the modifications and/or additions concern essential parts of the contract and if the rights of the participants are substantially modified, each participant with an existing and paid registration will be informed separately with the possibility of giving his agreement.
